This tournament will be run in accordance with, but not limited to, the Badminton World Federation (BWF) Statutes and general competitions regulations. In the event of any dispute, the decision of the Tournament Referee will be final.

Scoring System

Best of three games to 21 points extended up to 30points, as per the Laws of Badminton (BWF Statute 4.1)

The Draw will take place on **Tuesday, 25th November 2025**.

The Draw will be conducted on BWF tournament software.

The Draw shall be published on the Rising Star Badminton Academy Facebook page and Sri Lanka Badminton Website.

Seeding shall be done by Organizer and approved by the Referee.

The last date for withdrawal of entry into any event, without penalty, shall be **24th November 2025**. Such withdrawals should be notified in writing to the Referee via email sanjeewabac@yahoo.com and an acknowledgment obtained. If no acknowledgement is received within 24 hours, Tournament Secretary should be contacted immediately.

Minimum Age is Set as **35 Years** for any event in the tournament.

For the combined age categories minimum age will be as follows.

- Combined Age 90+ - 35 Years
- Combined Age 100+ - 40 Years
- Combined Age 110+ - 45 Years
- Combined Age 120+ - 50 Years
- Combined Age 130+ - 55 Years

Age will be calculated as of **01st December 2025** for all Events and adopted as done In all masters tournaments.

A Player can compete in maximum of 3 events. He / She is permitted to play only one single in an eligible age group, Double or Mix Double in another age group if eligible, Double or Mix double in eligible combined age category or selected one from each age group and combined age category.

In Doubles Event the doubles partner should also enter the double event separately when applying.

The closing date for all entries received to the ON-LINE Link shall be at SL time 23.59 hours. All entries submitted after the closing date as well as entries with any technical errors shall be rejected. After closing of entries withdrawals only will be accepted until the last date of withdrawals without penalty. If no objections are received before Monday 17th November 2025, 23.59 hours, the entries shall be deemed to be correct. Complaints/Objections shall not be entertained thereafter.

All Players must enter the Date of Birth and all relevant details required in the Entry Form when submitting the entry and shall produce the NIC, Passport or Birth Certificate when requested by the Referee and/or Tournament Organizing Committee.

If any event has less than 6 entries, entries will be assigned to the nearest lower group only with the consent of the player/s.

Play will be in accordance with the Laws of Badminton as mentioned on the web site of BWF and SLB. Tournaments Regulations / General Competition Rules will be according to BWF as adapted by SLB. All players shall be subject to the Players Code of Conduct of BWF

*All events are as per the timetable system; Matches will be forfeited if the player/s is/are not present at the time of play when the match is scheduled. However, a ten (10) minute grace period shall be allowed. No postponements shall be allowed, under any circumstances.

Award Ceremony:

During the Award Ceremony, players should wear tracksuits/ sportswear. (No sandals or slippers permitted)

Awards will be given out as and when the event is over.

Shuttles	Dayal 77 feather shuttlecocks shall be used for all the events. However, the Referee shall have the right to decide on any change if required.
Competition Rules and Regulation	Relevant Badminton World Federation Regulations as adapted by SLB, shall be applicable to this competition.
Medical Team	Medical Team/ Physiotherapy will be on duty throughout the tournament at the tournament Venue.
Doping Control	Doping control in badminton, in accordance with BWF Anti-Doping Regulations, will be carried out. Athletes are responsible for any substance found in their body. Before an athlete takes any medication, they should check with their doctor, and if necessary, get a Therapeutic Use Exemption (TUE) as stated in antidoping regulations. A Competitor will be permitted to substitute a partner in doubles, XD or combined age group if the original partner is prevented from playing through illness, injury, or other unavoidable hindrance. The affected player will not be allowed to play in any other event throughout the tournament. Such proposed substitute shall be notified to the Tournament Referee in writing before the commencement of that event. Such substitution shall not be of a higher rank than the affected player. The substitute player should not have entered the same event separately. Such requests must be submitted in writing prior to the start of the particular event.

Special Notice*

The Referee shall be in overall charge of the technical details, and the conduct of the tournament and the Referee's decision shall be final and binding.

If any circumstances not covered by this prospectus will be decide by the Tournament Referee.

The decision of the umpire shall be final on any point of fact in the match of which he/she is umpiring and shall not be questioned.

Tournament Referee

All disputes regarding the technical details of the Tournament shall be referred to the Referee or any administrative matters relating to the conduct of the tournament to the Tournament Committee. On all matters connected with the conduct of the tournament and on any administrative matters not provided for, the decision of the Tournament Committee shall be final and binding on all participants.
