Shuttles	An approved feather shuttlecocks shall be used only for open events, and all junior events will be played in Nylon shuttles. However, the Referee shall have the right to decide on any change, under a force nature situation.					
Competition Rules & Regulation	Relevant Badminton World Federation Regulations as adapted by SLB, shall be applicable to this competition. Final decisions on matters that are not covered will be at the discretion of the SLB Tournament organizing committee.					
	Clothing and advertising will be permitted in accordance with the tournament regulations of the Badminton World Federation. (GCR 20 - 24)					
Clothing & Advertising	It is recommended that the player's name on the back of clothing should be identical with the name registered as the Last Name (or an abbreviation thereof) in the BWF/ SLB Player database. Last Name is defined as the family name, surname or similar name under the respective naming protocol. (GCR 23.3)

	Recommended from Quarter Finals onwards: 1. Doubles partners must wear clothing of the same color. 2. Opposing players must wear clothing of significantly different colors.					
Medical Team	On court Doctor, an Ambulance and a Medical Team will be on duty throughout the tournament at the tournament Venue.					
Doping Control	Doping control in badminton, in accordance with BWF Anti-Doping Regulations, is conducted out-of-competition and in-competition with the collection of urine and/or blood samples. Athletes are responsible for any substance found in their body. Before an athlete takes any medication, they should check with their doctor, and if necessary, get a Therapeutic Use Exemption (TUE).  different name will result in immediate disqualification and may lead to further
 disciplinary action.
- All participants in the Open Events must be 14 years of age or older as of 1st January 2025.
