After the closing date, the BWF Online Entry System will send a notification to all participating Member Associations confirming receipt of final entries. Receipt of this notification is the conclusive evidence of receipt of entries before the deadline. The Member Associations should contact BWF immediately if such notice is not received by the Wednesday (the next day of the entries closing date) by noon BWF Headquarters time (+08.00h GMT) following close of entries. Under 19 All players must be under 19 years old throughout the calendar year of the tournament. i.e. born on or after 1st January 2007. The minimum age for all players shall be 12 years old, i.e. born on or before 31st December 2012.																																			
Under 17 All players must be under 17 years old throughout the calendar year of the tournament. i.e. born on or after 1st January 2009. The minimum age for all players shall be 12 years old, i.e. born on or before 31st December 2012.																																			
Under 15 All players must be under 15 years old throughout the calendar year of the tournament. i.e. born on or after 1st January 2011. The minimum age for all players shall be 10 years old, i.e. born on or before 31st December 2014.																																			
Under 13 All players must be under 13 years old throughout the calendar year of the tournament. i.e. born on or after 1st January 2013. The minimum age for all players shall be 8 years old, i.e. born on or before 31st December 2016.

Competition Rules & Regulation	Relevant Badminton World Federation Regulations shall be applicable to this competition.
Clothing & Advertising	Clothing and advertising will be permitted in accordance with the competition regulations of Badminton World Federation. (GCR 20 - 24) The player's name on the back of clothing shall be identical with the name registered as the Last Name (or an abbreviation thereof) in the BWF Player database. Last Name is defined as the family name, surname or similar name under the respective naming protocol of the Member count. (GCR 23.3) <u>MANDATORY CLOTHING REGULATIONS</u> 1. Name of the player is MANDATORY from the first day of the event. 2. From First day onwards, doubles partners must wear clothing of the same colour. 3. From First day onwards, opposing players must wear clothing of significantly different colours.
On Court Doctor	On Court Doctor will be on duty throughout the competition at the tournament venue.
Doping Control	Doping control in badminton, in accordance with BWF Anti-Doping Regulations, is conducted out-of-competition and in-competition with the collection of urine and/or blood samples. Athletes are responsible for any substance found in their body. Before an athlete takes any medication, they should check with their doctor, and if necessary, get a Therapeutic Use Exemption (TUE).
