## Rules & Regulations

1	<b>Summer Season All Island Open Badminton Championships 2021 organized by Central Province Badminton Association together with Nuwara Eliya Badminton Association Affiliated to Sri Lanka Badminton will be held from 20<sup>th</sup> to 27<sup>th</sup> April at the Nuwara Eliya Municipal Council Indoor Stadium. Main Sponsor is Li-Ning.</b>
2	All Events will be National Ranking Level I Events
3	Entry Forms are available at SLB office and on the SLBA website and should be handed over to SLB @ Maitland Place, Colombo 7, <b>from 09:00 am – 05:00 pm on weekdays &amp; 09:00 am – 01:00 pm on Saturdays. Please obtain a Receipt of the Entry &amp; Payment made.</b>
4	All Entry Fees should be paid at the time of submitting entry. Entry is not officially accepted if payment is not made with the entry form to SLB. All Cheques should be drawn in favor of “Sri Lanka Badminton Association” and crossed “Account Payee Only” or fees deposited to Account Number <b>0002323122</b> of Bank of Ceylon, Torrington Branch – Colombo – 07, and the deposit slip handed over with entry form. <b>Final acceptance of Entry is in the M&amp;Q list.</b>
5	Age will be calculated as at <b>01 January 2022 for all Junior Events</b> and at <b>01 January 2021</b> for Veteran and Masters Events.
6	Feather shuttlecocks of a Li-Ning brand or alternative shuttlecocks of speed 75 will be used for all events . <b>Nylon shuttle will be used for Under 13 Age group.</b>
*7	<b>Competitors will be allowed to take part in only in one age category and any number of open events. Participants for Open Events should be above 15 years of age as at 01<sup>st</sup> January 2021</b>
8	The Championships will run on a <b>knock out basis</b> and all matches will be played per the rules and regulations of Badminton approved by the <b>BWF</b> and as <b>adopted by SLB</b> . All players will be subject to the <b>Players Code of Conduct of BWF</b> . Violation of same would form the basis for disciplinary action as deemed appropriate by SLB. It is <b>Mandatory</b> that from <b>Quarter Final</b> onwards, the opposing players in each match shall wear significantly different colors from each other. It is <b>Mandatory</b> for <b>Doubles Partners</b> to wear the same colors of shirts from <b>Quarter Finals</b> onwards.
9	If a player/ pair is disqualified for any offense within or outside the court, the result of the last match played by that player/pair will be cancelled and a walkover awarded to the opponents of that last match, prior to the disqualification.
10	The tournament committee <b>may cancel</b> an event in the Championships if there are <b>less than four (4) entries</b> . For <b>Veterans events, if there are less than (4) entries, the organizer will amalgamate these entries into the nearest lower age group. If Over 30 age group has less than 4 entries, the event will be cancelled or amalgamate to Open events.</b>
11	Depending on the number of entries, the Tournament Committee may conduct qualifying rounds. <b>If there will be an excessive number of entries, matches will be started before the scheduled dates and in separate venues, if needed.</b>
12	Players are entitled to a minimum of 60 minutes’ rest period between any two matches.
13	Players must be <b>punctual</b> and any player who does not turn up for his/her match at the time allotted, will be liable to have a walkover given against him/her. <b>Ten minutes (10) grace</b> will be allowed. No postponements shall be allowed under any circumstances.
14	Competitors shall be allowed to play with the Doubles Partner nominated by them in the entry form. <b>Partner’s name and Date of Birth should necessarily be indicated</b> in the Entry Form. <b>Entry forms without partner’s name and date of Birth will not be accepted.</b>
15	No substitutions are permitted for seeded players in any doubles events. All other competitors will be allowed to substitute a partner if his original partner is prevented from playing through illness, injury or other unavoidable hindrance. The affected player will not be allowed to play in any other event on that day. Such proposed substitute shall be notified to the Tournament Referee or Deputy Referee or to an Appointed Official in writing, before the commencement of that particular event. Such substitution <b>should not be of a higher rank</b> than the original player and the new combination should <b>not be of a standard higher</b> than the original combination. The substitute should not have entered the same event separately.
16	<b>The Referee shall be in overall charge</b> of the tournament of which a match forms part. The <b>decision of the Umpire</b> shall be final on any matter of fact in the match of which he/she is umpiring.
17	All disputes with regard to the Championships shall be referred to the Referee or the Tournament Committee. On <b>all matters connected with the Tournament</b> and on <b>any matters not provided for, and all decision of the Tournament Committee shall be final and binding on all participants.</b>
18	If a player concedes a walkover in any event due to injury/illness or absence, he/she will not be permitted to compete in any other event of the tournament on the <b>same day. This does not apply for all Senior Events(Over 35 Age)</b>
<b>* Please Note the minimum age mention in this clause should be 14 years and not 15 years</b>	

19	Applicants must be fit and in good health and absolutely relieve the organizers and <b>such persons involved in the organization of the Summer Season All Island Open Championship</b> , of any responsibility for any injury, loss or damages to his/her property which he/she sustain in the courts or in connection with the above tournament.
20	Participants in Senior/Junior Events must produce the NIC, Passport or Birth Certificate when requested by the <b>Tournament Committee. It is compulsory that the Date of Birth should be entered in the Entry Form.</b>
21	Entry forms should be handed over to SLB at Maitland Place, Colombo 07.No postal Entries are acceptable.
22	<b>Entries will be closed on 01.04.2021 at 6.00 pm.</b> at SLB, Maitland Place, Colombo 07.
23	Entries <b>sent by fax</b> will not be accepted. Incomplete entries too will not be accepted.
24	<b>Entry list (M &amp; Q) will be published on SLB Web Site and displayed on the notice boards at SLB from 07.04.2021. All participants should check the list and ensure your name in the list.</b>
25	<b>The Draw will take place on 10.04.2021 at 11.00 am. At No. 02, Cambridge Place, and published on the SLB Notice Board and SLB web.(<a href="http://www.srilankabadminton.lk">www.srilankabadminton.lk</a>). The Draw will be conducted on tournament software of BWF and can be viewed live on the SLB FB page.</b>
26	Prize Money Offered for the Championship is Rs. <b>500,000.00</b> Certificates & Trophies/Medals will be awarded to all Winners, Runners-Up & Semi-Finalists of the Championships, depending on the number of entries and <b>according to the Tournament Policy.</b>
27	The last date for Withdrawal without penalty will be the <b>09.04.2021</b> . Such withdrawals should be notified in writing to the SLB Secretariat and an acknowledgment obtained. Withdrawal after the draw is published on the <b>10.04.2021</b> will carry a penalty of Rs.2000.00 If the player fails to make the penalty by due date, he <b>may</b> not be entertained for future tournaments. The due date will be 14 days after the conclusion of the tournament.
