General Conditions

- 1 It is compulsory that all invited players participate in the trials**
- 2 The final squad of (6) MEN & (6) WOMEN players will be selected from this trial. The basis would be (2) from singles trials and (2) Pairs from doubles trials. If the same player gets selected for both Singles and Doubles the selectors will determine the basis of making the squad. This number includes the reserves.**
- 3 Depending on the number of players permitted by the NOC / MOS, the team will be selected from the squad.**
- 4 If any player out of those invited is unable to face this trial, through illness, unavailability or any other reason, He / She will have to perform EXCEPTIONALLY WELL BY WINNING at the SLBA Ranking tournaments to be conducted in March, in order to be INVITED TO THE SQUAD.**
- 5 Once the squad is selected all players should train together as a team under the National Coach.**
- 6 We recommend that for a period of (3) months after the trials, the squad trains uninterrupted under the coach and TOURS OR OTHER DISRUPTIONS are NOT made to interrupt the training. The focus should be on the CWG.**
- 7 The SLB administrative procedures such as signing of the Players COC etc: should be made compulsory.**
