**CALL FOR APPLICATIONS - BWF LEVEL 01 COACHING EDUCATION COURSE (2024)**

I am pleased to inform you that the Coaching Development Committee (CDC) of Sri Lanka Badminton will be conducting BWF Level 01 Coaching Education course from March 2024. This course has been planned to empower and improve the expertise of coaches in our badminton community.

The CDC is now inviting application from qualified candidates who meet the necessary prerequisites for the following Coaching Education courses.

In addition to the specific requirements for each course (Annexure -1), candidates should satisfy the following basic criteria:

- Citizenship: Applicants must be citizens of Sri Lanka.
- Age: Candidates should be at least 20 years old.
- Player Status: Applicants should not be current Junior or open-ranked players.
- Good Standing: Candidates must be in good standing with Sri Lanka Badminton.
- Coach Registration: Candidates should have a registered coach under Sri Lanka Badminton. If not already registered, they must apply for registration before submitting their application.

Education: O/L (Ordinary Level)

Entry Qualification: Successfully completed SLB Level Two (2) Training Program or National champion in all five events or world rank holder below 100 in singles events or below 75 in doubles events in an open event.

Coach Experience: Two years after SLB Level 2

Service to SLB/Province/Sector: Recommendation by the respective association

\*To become eligible for BWF Level 1 coaching certification, individuals are required to successfully fulfill the requirements set by the Badminton World Federation (BWF). Completion of the BWF prerequisites is essential for aspiring coaches seeking to obtain the BWF Level 1 coaching certification.

**"According to the decision made by the General Committee of Sri Lanka Badminton, if there are insufficient qualified applications to occupy the available slots, the CDC will consider other applicants based on their rankings/qualifications to fill the gaps."**
